

GERMAN DUE DILIGENCE ACT WITH HOHENSTEIN

German Due Diligence Act – Valid since 1st of March 2023

- \rightarrow German companies with more than 3000 employees are concerned.
- → From 2024, the scope of application will be extended to companies with more than 1000 employees.

The scope of application extends to own business units, direct and indirect suppliers if there are indications of human rights violations and environmental damage.

WHAT IS REQUIRED?

RESPECT FOR HUMAN RIGHTS & ENVIRONMENTAL DUE DILIGENCE

- Adopt a policy statement
- Establish a risk management system
- Conduct a risk analysis
- Anchoring preventive measures
- · Establish corrective measures in case of violations
- Establish a complaints procedure
- Documentation and annual reporting

RISK AREAS
